Die NPD und andere Rechtsextreme nutzen bei ihrem "Kampf um die Köpfe" Comics, andererseits sollen die populären Bildergeschichten in der politischen Jugendbildung und im Schulunterricht der rechtsextremen Meinungsbildung aufklärerisch entgegenwirken. Doch für einige Comics gegen Rechts gilt: Gut gemeint ist nicht immer auch gut gemacht. Generell herrscht ein großer Mangel an Wissen über die gesellschaftspolitische Bedeutung, über die Wirkungs- und Einsatzmöglichkeiten von Comics. Werden hier Gefahren für die Gesellschaft und Mittel zu ihrem Schutz sträflich übersehen? Welches bildungspolitische Potential steckt in Comics? Über 20 namhafte internationale ExpertInnen analysieren in diesem Buch im interdisziplinären Rahmen Inhalte, Funktionen, Mechanismen und Wirkungen der "Comics von Rechts" und der "Comics gegen Rechts". "Durch mehrere Verdienste ragt dieser wissenschaftliche Sammelband aus der Menge der Comic-Sekundärwerke und politischen Fachbücher heraus. Zum einen wird hier zum ersten Mal das Titelthema von allen Seiten her bearbeitet. Hier werden nicht nur Comics zum Thema analysiert, sondern auch konkrete Modelle für den praktischen Einsatz im Unterricht und der Bildungsarbeit vorgestellt. Wer mit 'Comics gegen Rechts' arbeitet, sollte wissen, welche 'Comics von Rechts' es gibt. Wer Comics im Schulunterricht einsetzt, sollte nicht nur eine kritische Sicht auf die Inhalte haben, sondern auch erkennen können, ob und welche Stereotypen sich darin befinden und wie man mit ihnen umgehen kann. Daher ist es nur folgerichtig, dass sich die meisten Aufsätze mit der Darstellung der NS-Zeit und des Holocausts in Comics beschäftigen und der Verwendung dieser Comics im Unterricht. Gerade hier kommt der weitere große Verdienst des Sammelbands zu tragen, nämlich die interdisziplinäre Offenheit, die verschiedene Perspektiven, Meinungen und Ansätze zugelassen hat. Hier treffen Autoren mit unterschiedlichen, zum Teil konträren Ansichten zu bestimmten Comics aufeinander und geben damit entscheidende Anstöße für eigenes Reflektieren der besprochenen Comics. Viele der thematisierten Comics kennt man auch als Graphic Novels, als Sach- und Geschichtscomics aus den aktuellen Besprechungen des Feuilletons her und als Gegenstand akademischer Veranstaltungen. Wer hier mitreden will, wird auf diesen Sammelband nicht verzichten können. Dabei dürfte dieses Buch auch dem eher allgemein als speziell interessierten Comicleser einen neuen Blick auf die Möglichkeiten (aber auch die Grenzen) des Mediums öffnen. English is the language of science today. No matter which languages you know, if you want your work seen, studied, and cited, you need to publish in English. But that hasn't always been the case. Though there was a time when Latin dominated the field, for centuries science has been a polyglot enterprise, conducted in a number of languages whose importance waxed and waned over time—until the rise of English in the twentieth century. So how did we get from there to here? How did French, German, Latin, Russian, and even Esperanto give way to English? And what can we reconstruct of the experience of doing science in the polyglot past? With *Scientific Babel*, Michael D. Gordin resurrects that lost world, in part through an ingenious mechanism: the pages of his highly readable narrative account teem with footnotes—not offering background information, but presenting quoted material in its original language. The result is stunning: as we read about the rise and fall of languages, driven by politics, war, economics, and institutions, we actually see it happen in the ever-changing web of multilingual examples. The history of science, and of English as its dominant language, comes to life, and brings with it a new understanding not only of the frictions generated by a scientific community that spoke in many often mutually unintelligible voices, but also of the possibilities of the polyglot, and the losses that the dominance of English entails. Few historians of science write as well as Gordin, and *Scientific Babel* reveals his incredible command of the literature, language, and intellectual essence of science past and present. No reader who takes this linguistic journey with him will be disappointed.

In the opinion of some historians the era of fascism ended with the deaths of Mussolini and Hitler. Yet the debate about its nature as a historical phenomenon and its value as a term of historical analysis continues to rage with ever greater intensity, each major attempt to resolve it producing different patterns of support, dissent, and even hostility, from academic colleagues. Nevertheless, a number of developments since 1945 not only complicate the methodological and definitional issues even further, but make it ever more desirable that politicians, journalists, lawyers, and the general public can turn to "experts" for a heuristically useful and broadly consensual definition of the term. These developments include: the emergence of a highly prolific European New Right, the rise of radical right populist parties, the flourishing of ultra-nationalist movements in the former Soviet empire, the radicalization of some currents of Islam and Hinduism into potent political forces, and the upsurge of religious terrorism. Most monographs and articles attempting to establish what is meant by fascism are written from a unilateral authoritative perspective, and the intense academic controversy the term provokes has to be gleaned from reviews and conference discussions. The uniqueness of this book is that it provides exceptional insights into the cut-and-thrust of the controversy as it unfolds on numerous fronts simultaneously, clarifying salient points of difference and moving towards some degree of consensus. Twenty-nine established academics were invited to engage with an article by Roger Griffin, one of the most influential theorists in the study of generic fascism in the Anglophone world. The resulting debate progressed through two 'rounds' of critique and reply, forming a fascinating patchwork of consensus and sometimes heated disagreement. In a spin-off from the original discussion of Griffin's concept of fascism, a second exchange documented here focuses on the issue of fascist ideology in contemporary Russia. This collection is essential reading for all those who realize the need to provide the term 'fascism' with theoretical rigor, analytical precision, and empirical content despite the complex issues it raises, and for any specialist who wants to participate in fascist studies within an international forum of expertise. The book will change the way in which historians and political scientists think about fascism, and make the debate about the threat it poses to infant democracies like Russia more incisive not just for academics, but for politicians, journalists, and the wider public.

At a time when Europe is growing together, cooperation between countries is becoming increasingly necessary. One of the main reasons for pursuing transnational spatial development is to attain a common understanding of the facts of spatial planning. Hence, the INTERREG III B project "COMMIN" sought to establish a common communication basis for the exchange of knowledge and experience in spatial planning and thus to foster and develop this understanding in the Baltic Sea region. Therefore, on the basis of a standardized structure the COMMIN project partners prepared basic information about institutional settings and spatial planning systems and compiled a glossary of key terminology in spatial planning accompanied by a varying range of fact sheets with respect to planning cases taken as examples. The readers will now find on www.commin.org the whole range of information covering the respective national languages as well as English translations, although in some countries official translations for these issues were lacking. The project partners were aware of the fact that each translation requires a balancing act between legal precision and communicable classification and, at the end, is a question of definition power and of different senses for semantics. The German text on hand (status December 2006) one information package out of eleven was prepared by a team comprising planners, lawyers, economists, and administrative academics. Actually no other publication treating this subject in English exists and it will hopefully contribute not only to understanding planning issues in Europe but also to transferring in this respect information and knowledge within the country. Anyway, being aware of differences between countries is a point of departure for the mutual understanding process.
